
1. That the Educational Society shall abide by the instructions/rules issue by the Govt. from time to time.

11. That the school shall not be closed without giving notice both the parents/DEO and Competent authority at least (6) months before.
12. That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
13. That the society shall submit proposals for renewal of provisional recognition sufficiently in advance i.e., at least (6) months prior to the date of expiry of the renewal.
14. That additional sections/ higher classes should not be opened without prior permission of the competent authority.
15. That the recognition is accorded to the society and no other society or body can open a school on their behalf.
16. The recognition is accorded to open the school premises in the locality and there shall not be any change in the premises or locality.
17. The society shall provide, the necessary material even if it costs more than the deposit amount.
18. Admission should be made on the basis of record sheet issued by the private recognized / ZP/Govt./Aided schools only T.Cs/Certificates issued by the Secretary, DCEB, Mahabubnagar as Bonafide candidate.




Subject to the following conditions.



23. The Management shall handover the school premises whenever required to this department / Government for emergency purpose (Exams/ Elections etc.) without any deviation of the orders.


The recognition now granted is liable for withdrawal by the competent authority for violating the rule as prescribed in the G.O's cited and instructions issued by the authority from time to time.
